Karnataka State Report on the Implementation of the SCs&STs (Prevention of Atrocities) Act 1989 in Karnataka in the calendar year 2013 With recommendations to the Chief Minister (Chairperson, SVMC under Rule 16(1)i) CMs and Political Parties Report Card

Siddu gets an 'A', Kumaraswamy 'C' all others 'F'

Under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Rules 16(2), the State level vigilance and monitoring committee (SVMC) meeting is mandatory in the months of January and July each year. It has met only once in 2013 against the mandatory two meetings. The present government has issued the notification constituting the SVMC under Rule 16(1) on 19 July 2013, and met on 7 November 2013.

Given that the rules were notified on 31 March 1995 and that SVMC meetings were conducted only on 11 March 2000, 12 December 2006, 27 September 2010 and 7 November 2013, the score card of the state stands at a dismal 4 meetings conducted out of the mandatory 38. Therefore in fulfilling its constitutional mandate towards the SCs and STs under the Act the state scores 4 on 38—just 10.5%, a dismal 'F'. It must also be noted that none of the meetings were held in January or July as mandated by the law.

The score cards of the chief ministers and their parties are given below.

The present chief minister has begun well by conducting the mandatory meeting, and earns an 'A'. H D Kumaraswamy is the only other CM with a respectable score having conducted one of the three mandatory meetings, earning him a 'C' grade. B S Yeddyurappa conducted one of seven. All other CMs fail miserably—most having not conducted a single meeting. S M Krishna, in whose term the Kambalapalli massacre took place conducted just one of the mandatory nine meetings he was supposed to. The rate of SVMC meetings is eerily close to the dismal conviction rate. The record under president's rule follows the same pattern.

The record when compared party-wise is not much better, though all parties profess social justice. Only Janata Dal (Secular) has any respectable score, though only just.
